4. **Tax Collectors Suspense List - ( Discussion and Action )**

Amy Snell- Tax Collector was present to discuss Suspense List. She stated the list is presented to BOF for approval and is not counted as income.

Tim asked, "What happens to the ones that don't pay"? Amy answered, "It goes against their credit rating as the debt is sent to a Collection Agency.

Tim asked if the list is or can be posted online. Amy said it is not currently but can be posted or viewed at Town Hall.

Emile asked how successful has it been to retrieve debt on list. Amy answered pretty satisfied with the results. The list is current to the 2012 Grand List to date.

Amy mentioned after 7 years of delinquent taxes, your name shows on the list. Money collected from the list goes to the General Fund.

Emile asked if the town has any authority to enforce payment. Tim asked about fees to Collection Agency. Amy said 15% on top of what is owed is their fee. Amy will email BOF members, as well with having hard copies of updates in the future.
