1. Call to Order;

2. Pledge to the Flag;

3. Status Report from Economic Development Coordinator;

In attendance: Sam Eisenbeiser; (EDC Consultant) paid by the town and Brett Mastroianni (EDC Chairman).

- D. Meetings with Tribal Chairman, Rodney Butler are in works for possible economic development on Tribal Land in North Stonington. Also talk of Sewer Hookup in discussion.
- E. Charlie Steinhart asked question; "What progress does the taxpayer see"? Answer given was; Economic gardening. Basically a lot of towns going after the same businesses and having someone pursue them keeps North Stonington competitive with other towns.
- F. Sam has met with most businesses that are not home based.
- G. Website paid by the town is up and was given as GoNosto.com.
- H. Brett suggested coming to more meetings. EDC meets the third Thursday of each month.

- I. Charlie Steinhart suggested that the Grand List be increased and we should be marketing our town for new business.
- J. EDC has been actively involved in the Sewer Study which is very important to attracting new businesses.
- K. EDC has been working on faster turnaround times for permits with Planning and Zoning.
