3. Rink preparation for Winter Season-Update from First Selectman Mullane regarding courts. An A₂ Survey required for disturbing soil. Survey was done. Plan was approved at PZC meeting on September 8th. DEP should not be an issue. Planning and Zoning decision to Nick Mullane by Thursday of this week. Well will be upgraded at Fire Company and lines will be installed at the Rec Area. Lights will be installed with usage switch. Solar has been proposed for the Area. Will aim to put ice hockey and volleyball area by end of fall season. Lights and water will not be done until next year. Mr. Mullane will report at October meeting on court progress. The additional \$65,000 for the area was approved in the 2011-12 budget in addition to original grant funds.
