- **b.** Plan of Conservation & Development Update: There is a POCD Steering Committee meeting on February 12, 2024, at 6:00pm at the New Town Hall. There was an extension granted and Planning and Zoning will meet in March to adopt the POCD and once that is approved it should be good for 10-years.
