5A. NSVFC Tanker Truck Update

a. Chief Steinhart V provided an update on the new tanker truck, which was received on Thursday, June 17 and put into service on Tuesday, June 22.

5B. NSVFC Carryover Discussion

a. Chief Steinhart V provided clarification regarding the request from the NSVFC to carryover the unspent funds in the Per Diem Staffing Line Item (B26.14).
Discussion followed. Motion by First Selectman Urgo to approve the North Stonington Volunteer Fire Company to retain funds not to exceed \$10,000 as a one-time event in the Per Diem Staffing line, 2nd by Selectman Kincaid; motion approved 3-0-0
