- 1. Call to Order/Roll Call: Meeting called to order at 6:00pm, First Selectman Mike Urgo, Selectman Bob Carlson, and Selectman Nita Kincaid in attendance.

- 3. Central Administration Space needs
 - a. Board of Education Chair Christine Wagner made a presentation on the space needs for Central Administration within the old Middle High School, 298
 Norwich Westerly Road. Discussion followed.
- 4. School Building Repurposing Committee preliminary update
 - a. Toula Balestracci, chair of the School Building Repurposing Committee, gave an update from the committee. The committee created a scorecard to evaluate options for the old Middle High School. The Wheeler Library deed restriction on the building limits it to educational use. Discussion followed. Motion for an RFP to go out for the demolition of the middle school wing and the high school wing and an RFP for interest in occupancy in the middle school wing by First Selectman Urgo, 2nd by Selectman Carlson, motion approved 3-0-0.
