BOARD OF SELECTMEN

Big issues pending but no budget yet! This seems to be a recurring challenge for the Town, as well as the State. But significant progress is continuing in Town: Phase II of the Center for Emergency Services will break ground shortly, construction management services for the proposed school modernization have been selected, and the Selectmen have recommended the funding of a professional administrative officer position, which would provide continuity of town operations. This year's municipal election may see no incumbents seeking re-election to the Board, consequently having an official in place with background on town issues, who is not subject to re-election every two years, will provide more stability in town administration. The cost for the proposed position would be offset by staffing consolidations elsewhere.

The Boards will continue to work on the budget until the State finalizes the municipal grants picture. Residents and taxpayers are encouraged to attend public meetings and hearings to provide input on public needs and services. As always, if you are interested in participating on a town board or commission, contact the Town Clerk or First Selectman's office at Town Hall for more information.

ASSESSOR'S OFFICE

The Renters Program for North Stonington renters runs until October 1st, so now is the time to apply. To qualify: one of the renters must be at least 65 years old; or renters must have qualified for social security disability payments and have a gross income of less than \$42,900 for a married couple or \$35,200 for a single person.

Veterans must have their DD 214 on file with the Town Clerk before October 1st to qualify for the veterans exemption on either their home or their motor vehicle. The basic exemption is \$6,000 off the assessment of the real estate or motor vehicle. Please note veterans with a disability who have reached the age of 65 must inform the assessor's office so their exemption will reflect the fact that you are over 65. Any disabled veteran that has had the disability rating increase must inform the assessor's office so that we can increase your exemption.

Personal Property Declaration Forms will be mailed on October 1st. Please complete the form as early as you can and return it to the assessor's office. Remember that there is a 25% penalty for failure to file before November 1st. The office is ready to assist you in completing the form so please ask if you need help.

Reminder: The department of motor vehicles does not inform the assessor's office when you sell a motor vehicle. If you transferred the license plate, the credit is automatic and you do not need to do anything, but if you return the plate, or do nothing with the plate, you will continue to be assessed for the motor vehicle that you sold or junked.

NORTH STONINGTON PUBLIC SCHOOLS

While the summer means a time for rest and recreation for the North Stonington Public Schools' faculty and staff, there will also be a bevy of activity taking place in preparation for the new school year. Last school year, North Stonington Public Schools received statewide recognition. Of the 1,148 schools in 200 Connecticut school districts, Governor Malloy recognized 116 schools as "Schools of Distinction," and North Stonington Elementary School and Wheeler High School were both recognized. The school district is not resting on its laurels. In preparation for the new school year, many of our staff will be taking advanced coursework or participating in professional development. Our principals will be working with their data teams in order to prepare for next year's instruction.

Central Administration is open during the summer months. If you have any questions regarding the upcoming school year, we ask that you contact your child's school first.

The 2017-2018 school year will begin on Wednesday, August 30th as a half day for grades 1-12, with faculty and staff present the two days prior to the opening. Pre-K and Kindergarten will begin on Friday, September 1st. School will be closed the following Monday in observance of Labor Day. Building principals will be communicating directly with families regarding summer events. Parents will receive a packet prior to the opening of school that will contain vital information, including important information about our food services program.

EMERGENCY SERVICES BUILDING COMMITTEE

During the January to March reporting period, final Specifications and Drawings for the Emergency Services Building were completed and reflected the re-engineered cost containment designs. These designs were modifications formulated to bring final construction costs in line with the town-approved \$6.3 Million budget. The bidding process was then initiated with these approved Drawings and Specifications.

The Town of North Stonington received eight bid submissions from general contractors and these were opened publicly on March 22, 2017 at 1pm. In reviewing the bid submissions, it was determined that Enterprise Builders, Inc. from Newington, CT is the lowest responsible and qualified bidder.

A meeting was held with representatives from Enterprise on March 30th in the offices of CREC in Hartford, CT. Enterprise provided both a detailed schedule and estimate and explained which potential subcontractors were being considered for award of the subcontracts for the work. The contractor demonstrated an in-depth understanding of the scope of work and phasing required to complete the project, based on the duration they provided on the bid form.

The contractor's pre-qualification and contracting status with the State of Connecticut was verified. The Town obtained performance reviews from the State of CT Department of Administrative Services. These were analyzed by Town Officials who made the determination that Enterprise Builders was the lowest responsible and qualified bidder. Based on the town's reviews of the bid submission, scope review meetings with CREC and the town, and the town's review of their qualifications, Enterprise Builders was recommended for the project.

Planning, Construction Compliance and Budgetary (cost to complete) Status Reporting is now under the supervision of CREC of Hartford, a company that specializes in Project Management and 'Clerk of the Works' Construction services. The Project Manager will be Mr. Michael Faenza in the employ of CREC. Mr. Faenza, an engineer with the CREC company has been affiliated with several successful projects in the area including the Police Building in Ledyard.

The contract for the North Stonington Emergency Services Building has been fully executed by the Town Selectmen, the Contractor and the USDA. In the coming days work will commence on setting up the Pre-Construction Conference with the USDA, which will mark the start of the Project. The reporting of status will be posted in the Town Hall corridor as well as in the Committee Meeting Minutes on a monthly frequency. Residents should be witnessing construction activity in the mid to late summer of this year.

TOWN CLERK'S OFFICE

Happy summer! This time of year is very busy in the Town Clerk's Office. Dog registrations were due in June. The fee was \$8.00 for a neutered or spayed dog and \$19.00 for those that are not. If you have not yet registered, please do; late fees increase by \$1 per month. If you no longer have your dog, please contact us to let us know.

July is the month to renew food service licenses. To operate a food service establishment, food catering service, or a traveling food vending business, you must obtain a valid license issued by the Town. All establishments are required to file a new application, or renew a current license, with the Town Clerk's Office no later than July 30th, 2017. The license fee is \$25.00 and it's in effect from July 1st, 2017 to June 30th, 2018.

On August 12th, the State of Connecticut is offering to anyone, resident or non-resident, a free one day fishing license good for fishing in the inland and marine districts. These licenses will be available three weeks prior to that date through the DEEP online sportsmen licensing system. Have a safe and joyful summer!

HEWITT FARM

2017 has already been a very busy and productive time at Hewitt Farm! We are especially excited this year by all the improvement projects that have been completed or are underway:

- This spring Troop 71 Eagle Scout candidate Jason Miner designed and built an attractive, safe bridge on a trail near the hayfields. He replaced a plank crossing, which was off farm property and harmful to an old apple tree. His project was very well executed.
- The North Stonington Garden Club completed a Letterboxing Discovery Trail for children. Maps are at the Dam bridge and the rear entrance off Hewitt Rd.
- Three other Troop 71 Eagle Scout candidates have presented their plans for projects that will be started this year: a bridge along the Dew Drop Inn Trail, a bulletin board information sign, and a series of plant/tree descriptive signs.
- The Community Garden Association has expanded its footprint and added 6 more plots so that more members of the community can participate.
- Volunteers will soon begin clearing an area along That Dam Trail to create a picnic grove overlooking the pond.



This spring we were fortunate to be able to hire local contractor, Gene Anderson who has the knowledge and experience needed for restoration and repairs of historic buildings like the 1750 Farm House. It is a part of our town's history that has architectural significance and is recognized by the State Historical Preservation Office. Replacement of weak structural beams in one area of the basement and repairs to the entrance facing the Green have now been completed. Next, we are looking forward to a Town Meeting to hear the Historical Society's proposal for the deteriorating Greene Gables building, so that voters may determine whether to save or demolish it.

The many Hewitt Farm trails are in good shape for a pleasant hike, with trail maps handy at all entrances or online from the town website (www.northstoningtonct.gov). Don't forget, dogs and horses are also welcome at the farm. Parking is available inside our Route 2 entrance or at the parking area near the end of Hewitt Rd. when you enter from Ryder Rd.

BOARD OF FINANCE

The Board of Finance has been working on the 2017/2018 Town Budget since March of this year. Currently the Board of Selectman have set the mill rate at 27 mills to pay day-to-day bills, but the current budget will not be covered by the 27 mills, and only the first half of the 2017/2018 tax bills are being sent out. The taxpayers could see increases in their tax rate, which would be affected by the State of Connecticut's cuts to the Town's revenues; this would be reflected in their January 2018 tax bill.

The Board of Finance has approved a budget to send to a Town Hearing to be held sometime in July. The budget that is being put forward to the Town Hearing will total \$18,631,256.00, which is an increase of \$260,905.00 from the 2016/2017 budget. The proposed mill rate will be 30 mills; that breaks down to an increase of 3 mills, with a .5 mill increase to current 2017/2018 budgets (split between Education and Town Government); 1mill for the approved School Modernization Project; and 1.5 mills to cover half of the State of Connecticut Governor's budget, which could be a loss of 2.2 Million dollars to the Town of North Stonington. The current State legislation session has ended with no budget and no foreseeable timetable on when there will be an approved budget.

The members of the Board of Finance have struggled over what is the most appropriate way to proceed, and after much deliberation and discussion, we feel that presenting a budget as proposed is the most fiscally responsible way to proceed, due to the knowns and unknowns. We hope that the tides change in our favor; however, all things taken into consideration, we feel that this is the most appropriate and responsible way to continue to provide the level of services that the people of the Town of North Stonington have come to expect and appreciate, along with the long term building projects which have been approved and go along with the Town's Plan of Conservation and Development.

NORTH STONINGTON AFFORDABLE HOUSING COMMITTEE



Ferry Crossing, Old Saybrook

The North Stonington Affordable Housing Committee hosted a successful bus tour, highlighting affordable housing developments in June. We visited Spruce Meadows in Pawcatuck and Ferry Crossing in Old Saybrook. Spruce Meadows has 43 apartments; 22 of which are affordable. Ferry Crossing has 16 rental units, 100% affordable. It is inspiring to think that North Stonington could provide such a choice in housing.

We may get a chance to see what could be done here in North Stonington as the Board of Selectmen has approved the development of a conceptual plan for affordable/mixed housing on a portion of Town property on Wintechog Hill. Watch for it.

Federal funding of the Community Development Block Grant, which funded the \$400,000 rehabilitation grant in North Stonington, is not certain at this point. This grant provided no interest loans to 16 income-qualified homeowners in North Stonington to repair their homes. The Town has fulfilled all training requirements to reapply for another round of funding should they choose to do so.

If you are interested in getting money for needed repairs, and qualify, inquire at the Planner's office for a letter of intent. That will help the Town be prepared to submit their application again to the CT Department of Housing for this grant.

TAX COLLECTOR

Due to the fact that the Town of North Stonington does not currently have an approved budget for the 2017/2018 fiscal year, the July bills will reflect the **First Installment only**, based on last year's tax rate of 27.00 mills. Once a budget is approved, you will receive the **Adjusted Second Installment**, which will reflect the Board of Finance approved mill rate, with a due date of January 1, 2018.

First Installment tax bills will be mailed out at the end of June. The last day to pay without interest being charged is August 1, 2017. For your convenience, payments may be made in the Tax Office in Town Hall. Office hours for the Tax Collector will be 9am to 4pm, Monday through Friday. The best way to avoid the crowds is to pay by mail. If you would like a receipt, please enclose a self-addressed stamped envelope. You may also find out how much you owe and make payments online by going to www.northstoningtonct.gov/payonline. Service fees for on-line payments are as follows; E-check \$2.00, Visa Debit \$3.95, all other debit or credit transactions 2.5% of payment amount.

SCHOOL MODERNIZATION BUILDING COMMITTEE

Time is flying and things are proceeding quite well with the School Modernization initiative. Since our last article in the Quarterly, the committee has spent quite a bit of time fine-tuning our budgets and design for the schools. We have just completed our "CD", construction design documents that will be presented to the State for final approval on June 22, 2017. A week or two after this meeting, we anticipate getting the "green light" to go out to bid with our design. Even with this "green light", we are still awaiting confirmation of funding from the State of CT to award any contracts. If you remember, the Town voted last May to approve the project pending State approval of funding. Once we receive confirmation of our funding from the State (which could be late June or into July), we will begin securing our construction partners and aim to put a shovel in the ground in mid to late August. We are still anticipating having our 2018-2019 Middle/High school students in the new building to start that year and the Elementary students beginning the 2019 year.

JUVENILE REVIEW BOARD

North Stonington has had a Juvenile Review Board since 1998. The Juvenile Review Board is a community-based program designed to act as an advisory board to assist the North Stonington Resident Troopers in the specific cases involving police/juvenile contact. The goal of the Review Board is to make effective recommendations to assist individual youths to avoid a repeated pattern of criminal behavior.

In October, 1997 a letter was sent to the Connecticut Supreme Court requesting the formation of a juvenile review board for North Stonington. The Board of Selectmen finalized the original make-up of the Board in May, 1998, with the appointment of seven members. The Review Board held its first meeting May 8, 1998, and disposed its first case that same month.

Members of the Review Board consist of a resident state trooper, a school representative, the town's youth recreation director, juvenile court probation officer, three at-large members and one alternate-at-large member appointed by the Board of Selectmen.

The Resident Troopers may refer cases to the Board in lieu of Juvenile Court. The Troopers will present the Juvenile Review Board alternative to the youth and his/her family. If the youth and the family agree, the Board will convene a hearing at their next meeting.

The Review Board will meet every month, unless agreed by the entire Board. Cases will be presented by the Resident Troopers, including recommendations made by the investigating officer. The case is then open for discussion. The Board then decides upon a recommendation that will be offered as an alternative to Juvenile Court. The purpose of the Board was expanded to also provide an option for juveniles who have violated the school truancy policies of North Stonington Public Schools.



NORTH STONINGTON VOLUNTEER FIRE COMPANY, INC

During the months of March, April and May of 2017, your volunteers at the North Stonington Volunteer Fire Company responded to a total of 81 emergency 911 calls. Of these calls 32 were medical response calls by volunteer firefighter EMTs; 3 were water emergencies; 4 were vehicle fires; 1 was a structure fire; 15 were motor vehicle accidents (some involved fatalities); 5 were mutual aid calls to assist surrounding townships; 2 were automobile lock-outs; 4 were hazardous material incidents; 1 was a chimney fire; 3 were brush fires; and 11 were false alarms.

Responding to these calls required 434 man hours of volunteers' personal time donated to responding to our town's emergencies; an average of 11 volunteers responded to all calls. Excluding the 32 medical response calls, there were 30 emergency calls during the daytime and 19 emergency calls during the after-hours timeframe.

Your volunteers at NSVFC also contributed an additional total of 249 man hours involving training and drills, in order to improve their proficiencies in life-saving skills. These drills included infection and bio hazard controls, CPR and AED training/refresher, RIT Operations (firefighter rescue), water flow, tanker shuttle involving several mutual aid fire departments, confined space rescue operations, and ladders.

AVALONIA

Avalonia invites all residents to come out and enjoy our properties. Our most recent acquisition is the Benedict Bengt Benson Preserve on Swantown Hill Road, which is approximately 90 acres. Enjoy the loop trail on the west side of the road.

Note the historic Parke Pond on Babcock Road just out of the village. You can hike from the Erisman Woodlands on Reutemann Road (¼ mile west of Hangman Hill Road) through Babcock Ridge and then onto the Donald R Henne Preserve (by walking 100 ft. west along Babcock Road) and continue through the Henne, all the way to Surrey Lane and Rt. 184.

Another excellent hiking location is the Reed-Mitchel property. Its entrance is on N.W. Corner Rd. Look for a green and white "visitor parking" sign on the south side of the road at a sharp bend between the two Anna Farm Rd. entrances. There are several well-marked trails through this wooded property. The Yannatos property, in the center of Clarks Falls, has a shorter loop trail and a display on the history of the former mill there.

This also includes free time to explore the Hill and choose lunch at a place of your choice. The Center has a bus that is handicapped accessible, but seating is limited, so reserve early!

PLANNING AND ZONING OFFICIAL/ LAND USE OFFICE

Join us this year! There are a few spots opening up on the Commission this November and we would love to have new members on board to help implement our Plan of Conservation and Development and facilitate investment in town – whether new construction or preservation of land. No experience is necessary, and we will be glad to help you get acclimated to your new role. This is an elected position, so if interested, the first step is to contact the Democratic or Republican Town Committee Chairperson.

The Planning and Zoning Commission identified its top priorities with respect to implementation of the 2013 Plan of Conservation and Development. We will focus on re-zoning the western end of Rte. 2 from Residential to Resort Commercial to attract investment to the under-utilized and undeveloped parcels that are suitable for development and to facilitate coordinated development that complements existing development in the area immediately surrounding Foxwoods Resort Casino, which includes parcels in Ledyard and Preston.



Second, with the help of the Affordable Housing Committee and Milone and MacBroom, we will complete a conceptual plan for a possible affordable housing development on a small portion of the town-owned parcels off Wintechog Hill, preserving over 70% as open space for passive recreation. This is a continuation of work started several years ago.

Small changes have been made to the Agricultural Regulations and others are being contemplated to establish a minimum size for an accessory apartment.

A Note on Zoning Enforcement: Just a reminder that Accessory Apartments, pools, and sheds, no matter how small, all require zoning permits. The process is quick and painless. Please come by the office and I would be happy to walk you through the entire process! For the business owners in town, please remember that banner signs of any kind are not permitted in an effort to maintain the character of our small rural town.

November 2017 is a time when seats on our town's boards and commissions need to be filled by residents who want to have an active role in our town's future. **July is a particularly important month for anyone interested in running for an office.**

There are necessary steps to take **as soon as possible** to become a candidate for one of the open positions in our town government. The steps vary depending on whether you are a Republican, Democratic or Unaffiliated voter.

DEMOCRATS: Contact the Chair of the North Stonington Democratic Town Committee (NSDTC), Mark Donahue, by email (donahuems@comcast.net) or cell phone (860-334-9204) to express interest. The NSDTC's purpose is to select and endorse candidates, as well as fund and run election campaigns. It is the sole body that interviews Democratic-endorsed candidates for municipal office.

Per its bylaws, NSDTC will call a meeting on July 18th at 5:00 pm for the purpose of selecting the party-endorsed candidates for each municipal office available. A majority vote of the NSDTC members who are present to vote will determine the candidates.

REPUBLICANS: Contact the Chair of the North Stonington Republican Town Committee (NSRTC), Brett Mastroianni, by email (brett@pawncct.com) or cell phone (401-954-7242) to express interest. The NSRTC's purpose is to seek out and recommend to the Republican caucus at least one qualified Republican for each office vacancy and to organize and direct general election campaigns.

A Caucus of enrolled NS Republicans will select the Republican Party-endorsed candidates, who must be registered NS Republican voters on the current Registrar's list. Their 2017 meeting to vote for Republican Party-endorsed candidates will be held at the Senior Center on July 24th at 6:30 pm.

UNAFFILIATES: An unaffiliated voter has two options: (1) to seek endorsement by the Democratic Town Committee (see Democrats above) or (2) to petition to be placed on the November ballot by obtaining an Application for Nominating Petition by contacting the Secretary of State. The petition must be filed with the Town Clerk by August 9th at 4:00 pm. More information is available from Norma Holliday, Town Clerk at 860-535-2877 ext. 21.
