- 1. **Call to Order**: 7:01pm, Members present: Chairman Dan Spring, Dan Smith, Paul Simonds, Carolyn Howell, Anne Akin, Michael Anderson Absent: Chris Hundt
- 2. **Emergency Management Services: Chief Charles A. Steinhart V**: A question and answer session between the BoF and the NS Fire Chief. A number of points were brought up.
 - a) Issue first brought up in 1993, and then went dormant. In 2012 attended statewide seminar to increase recruitment. Issue brought forward again in 2018, 2019, and this year.
 - b) Majority of calls are daytime calls. On average 6 volunteers show up to calls during the day. Of those 6 at least 2 are senior members (40+ yrs of service) and not all are certified at all levels.
 - c) Per Diems will be firefighter/EMT trained. Most likely will be off duty firefighters from nearby towns.
 - d) Cost will be for time and uniforms only.
 - e) Response time is expected to decrease by 2-4 minutes with Per Diems.
- 3. **BoF Alternate Vacancy & Applicant Reviews**: 4 applicants for position. Discussion covered town attorney's rendering that strongly recommends filling position with non-republican candidate as well as Town Clerk/Secretary of State's rendering that with only 2 alternates there is no minority representation violation if both are republican.

Paul Simonds nominates Brett Mastroianni to fill the vacant alternate position on the Board of Finance. 2nd Dan Smith. Discussion of candidates follows. Mike Anderson would nominate Sarah Nelson to fill the vacant alternate position on the Board of Finance but thinks we should have the candidates in to vet.

Nomination by Paul Simonds to have Brett Mastroianni fill the vacant alternate position on the Board of Finance. 2nd Dan Smith.

Vote: 4/2/0 Brett is seated as an alternate on the Board of Finance.
