The town owned property at 163 Wintechog Hill Road was suggested as a possible location for the facility. A group has discussed the creation of a non-profit organization similar to Stand Up for Animals in Westerly. Kasha Deshefy, Animal Control Officer, discussed the location with the Board of Selectmen and answered questions.
