 - 12 spoke in favor of maintaining it as town property. Both CC and KNSA submitted written reasons for retention of town owned property. Two residents spoke in favor of selling (to them)
 - The P&Z voted 4-1-0 to recommended not selling the property. Subsequently, the BOS supported the P&Z recommendation not to sell. The no voter felt they should not weigh in on BOS request.
- The 2023 POCD: continued Conservation & Recreation chapter work All
 - Juliet Hodge will guide the process
 - Ten properties have been identified to add on to our "like to acquire" list. Two properties from previous POCD list have been removed.
