- Discussion of a simple bridge over brook between Wintechog Hill Trail and North Stonington Citizen Land Alliance trail on the opposite side: A couple of 2x8 are needed.
- Postponing of any trail work discussed on Wintechog Hill property till after the confinement period. Believe we can do it and still keep our distance. We need to add blue circles trails are generally in good shape. Bill will propose a date for any of us available to go out and do it.
- Completed removal of 3 large trees on Hewitt Farm's Yellow and River Trails DeGoursey/Ricker
- Update on Boombridge Road Bridge construction work is continuing. We are not authorized to work there until the bridge is completed.
