For Firefly farms, a phone call to the property owner will be part of the process as well. Note: Bill to take this to Firefly farms (Dugan Brown) for his review, and it will subsequently be shown to the BOS for their approval.

- Hangman Hill Preserve cleanup Bob
  - o Bob cleaned up the area and rehung the COVID sign the Town put up.
- Draft letter to identified landowners (sent via email including Colgan comments)
  - o It was proposed to make the letter succinct and to eliminate references to our previous request. Bill will rewrite and send out to CC members for review and comments
- Budget item: Dues or membership for these organizations is acceptable but a donation in the
