- New Playground Equipment/Ideas: tabled for review at next meeting. Any new equipment must be received by June 30, 2022.

 Committee will plan to participate again.
- School Building Usage by Recreation Programs: Presently available to use school facilities on Saturdays. Dir Fabian will look into continued availability in January and also explore Volleyball times.

New Business:

- Rec Commission Appointees: M. Stark and H. Dugas have been appointed by the BOS.
- New Programs/Activities: exploring additional Yoga and Pilates programs. Winter floor hockey was identified as an opportunity.
- Donation Grace Fellowship Church: Commission motioned and approved a donation of \$300 to the Church in appreciation of the use of their recreation area for the basketball program.
- Budget FY 2022/2023: Commission reviewed the proposed budget. Motion to approve budget as amended approved. Some key areas noted:
 - Summer camp: addition of a counselor and an Assistant position recommended. Early registration pricing was reviewed, prior to 4/1 rate \$65/week, additional child \$45.
 Week 7 \$50. After 4/1 rates \$80/week, \$60 for additional child.
 - Office Supplies/Field/Shack: \$12,995 proposed for services and items related to care and improvements to fields and facilities.
 - Building: \$10,360 for fees to the Rec Building proposed.

 Motion approved and will be adopted at the next meeting.
