Several commissioning certifications are listed, however ASHRAE's Commissioning Process
Management Professional [CPMP] certification is not included. Kohler Ronan has received prior
confirmation from the State of Connecticut that CPMP certification is an acceptable
equivalent. Please advise if North Stonington would also consider ASHRAE's CPMP certification an
acceptable alternative.

North Stonington would accept CPMP certification as an acceptable equivalent.

3. On the School Modernization Building Committee Request for Qualifications/Proposals Commissioning Services for New Construction and Renovation we are looking for the submission requires two forms—Exhibits 1 & 2—which are not included in the attached RFQ/P. See item 5 on page 13.

4. Page 9, Item 15 states "all training should be recorded for future use if needed." Will the Commissioning firm be responsible for video recording the training?

Mechanical contractors should be responsible for their own recording and training.

6. Sustainable Engineering Solutions insurance exceeds the minimum amounts requested for each category, with the exception of the Professional Liability. SES has been the Commissioning Agent for over 50 CT school projects and has never been required to carry over 1 million dollars' coverage. Will this coverage suffice?

Coverage amounts stated are required by the Town of North Stonington for the project with no exceptions.

7. Page 3, first paragraph state" the construction documents are complete." Are any documents available?
