motion. Board votes 3-3-0 and the vote to approve the ARPA Funds Request does not pass. Mike Anderson, Sarah Nelson and Winona Berdine voted in favor for approval, while Gary Annino, Carl Johnston, and Amy Friend rejected the ARPA Funds Request.
