The Department of Energy and Environmental Protection's Fisheries Division is currently in the process of amending some CT inland sport fishing regulations. A new (as of 6/29/2023) provision of Section 26-113 of the General Statutes of

Connecticut require the Department of Energy and Environmental Protection to provide to each municipality for possible posting on its website a copy of a notice published in several newspapers throughout the state concerning the public hearing for these regulations. Here's the relevant text from the statute:

"The Commissioner of Energy and Environmental Protection, or the commissioner's designee, shall provide a copy of such notice to each municipality where such waters are located for publication of such notice on the Internet web site of each such municipality".


