

## Herman E. Sheets Family Forest

## This eighty-six acre parcel is a critically important watershed for the Pawcatuck River basin

For fifty-two years, the Avalonia Land Conservancy has preserved land in Connecticut, providing critical habitat for an extraordinary diversity of wildlife, protecting important watersheds and drinking water, and creating amazing opportunities for people to enjoy outdoor activities. To date, Avalonia has preserved over 4,300 acres in southeastern Connecticut.

In 2020, we are hoping to acquire the Herman E. Sheets Family Forest, an eighty-six acre property in the historic settlement area of Laurel Glen, one of the original villages of North Stonington. Our deadline to close is December 31, 2020 – if we do not acquire this land by that date, the land could be sold and developed.

A regional treasure, teeming with life, thrives in North Stonington.

The entire property is included in the Wood Pawcatuck Watershed which recently received a National Wild and Scenic River designation. This important watershed supports globally imperiled species, provides clean groundwater, and serves as the sole source of drinking water for more than 60,000 local residents. In addition, the Sheets Forest has a half mile of frontage on the Green Fall River, a forested river that has native and stocked trout.









The Herman E. Sheets Forest will provide opportunities for outdoor exploration and activities. The top of a large earthen dam provides a unique hiking trail with view to large ponds on both sides, while the remains of another stone dam can easily be seen along the Green Fall River. Historic stone foundations, a root cellar, and stone-walled scenic trails are located on the western side.

Due to a generous discount from the owner, the asking price of this valuable 86-acre property is \$325,000. At this time, we are very close to our
