

TOWN OF NORTH STONINGTON
NOTICE OF REFERENDUM
MAY 16, 2022

Pursuant to Connecticut General Statutes Section 7-7, a referendum of the electors and citizens qualified to vote in town meetings of the Town of North Stonington, Connecticut, will be held between the hours of 6:00 A.M. and 8:00 P.M. on Monday, May 16, 2022 at the following polling place: North Stonington Education Center, 298 Norwich-Westerly Road, North Stonington, Connecticut, for the purpose of voting on the resolutions presented to the Annual Town Meeting held May 2, 2022 regarding the Town budget for July 1, 2022 through June 30, 2023 and other resolutions. Voting tabulators will be used. Absentee ballots will be available from the Town Clerk's office.

The resolutions will be placed on the ballot under the following heading:

1. SHALL THE TOWN OF NORTH STONINGTON APPROVE THE ESTIMATES AND RECOMMENDATIONS OF THE BOARD OF FINANCE WITH RESPECT TO THE ANNUAL BUDGET INCLUDING GENERAL GOVERNMENT OPERATING: \$5,319,361; REDEMPTION OF DEBT: \$1,382,949; AND CAPITAL: \$408,655; FOR FISCAL YEAR JULY 1, 2022 THROUGH JUNE 30, 2023, IN THE TOTAL AMOUNT OF \$7,110,965?
2. SHALL THE TOWN OF NORTH STONINGTON APPROVE THE ESTIMATES AND RECOMMENDATIONS OF THE BOARD OF FINANCE WITH RESPECT TO THE ANNUAL BOARD OF EDUCATION BUDGET FOR FISCAL YEAR JULY 1, 2022 THROUGH JUNE 30, 2023 IN THE AMOUNT OF \$14,527,467?
3. SHALL THE TOWN OF NORTH STONINGTON APPROVE \$1,000,000 IN AMERICAN RESCUE PLAN ACT FUNDS TO REPLACE LOST PUBLIC SECTOR REVENUE AND FUND A PORTION OF THE DEMOLITION OF THE ONE STORY WING OF 298 NORWICH WESTERLY ROAD?
4. SHALL THE TOWN OF NORTH STONINGTON APPROVE AN ORDINANCE CREATING A MUNICIPAL PARK AND RECREATION CAPITAL AND NON-RECURRING EXPENSE FUND AND AMEND THE EXISTING ORDINANCE RECREATION COMMISSION SECTION 14-1 (c) AND FOR THE TOWN CLERK TO BE ALLOWED TO PUBLISH AN ABBREVIATED VERSION OF THE LEGAL AD REGARDING THE NOTICE OF PASSAGE OF THESE ORDINANCES?

Voters approving the resolutions will vote "Yes" and those opposing said resolutions will vote "No."
