A **MOTION** was made by Lisa Mazzella, seconded by Nick Mullane to move the call. **MOTION CARRIED UNANIMOUSLY.** Also present at the meeting were Board of Education Chairman Christine Wagner, Superintendent of Schools Peter Nero, Board of Finance Chairman Dan Spring, School Modernization Building Committee Chairman Pamela Potemri, and Douglas Gillette, Bond Counsel from Day Pitney. Moderator Bill Ricker stated the rules of the meeting and explained that he would adjourn the meeting at 8:30 to call for a referendum. Chairman Potemri of the School Modernization Building Committee gave a PowerPoint presentation regarding the phases of the project and the work of the committee. Petitioners John Olsen and Anthony Palazzolo discussed the costs of the project and the impact on the residents. Dan Spring, Chairman of the Board of Finance, discussed the financial aspects of the project and their impact on the town. Bond Counsel Douglas Gillette explained the bond resolution and the grant and reimbursement rates regarding the school project. Superintendent of Schools Peter Nero and First Selectman Michael Urgo discussed the implications to the town if the school project does not pass. Public comment and discussion followed regarding this issue.

Moderator Bill Ricker adjourned the meeting at 8:34 p.m. to the Referendum on February 8, 2018 between the hours of 6:00 a.m. to 8:00 p.m. at the New Town Hall Conference Room.
