Discuss and act upon WPCA's FY23 budget request. Members discussed the Budget request for FY23. Reichert presented staff's version of the budget request for consideration. Reichert asked for clarification on how the appropriate line items and their corresponding appropriation request. A discussion concerning the water testing and planning efforts underway and proposed for FY23 took place. The elements of the budget request were focused on an update to the Sewer Avoidance Plan, water testing, a regulation update which creates a sewer and water district within the Recreational Commercial Zone, and planning efforts in support of the upcoming POCD update. Chair Currier agreed to attend the Board of Finance budget hearings when scheduled.

Johnson moved to approve the budget request as amended, 2nd by Boissevain – passed unanimously.
